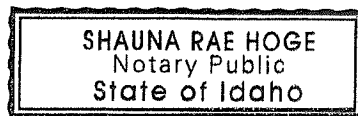

At the Republican State Convention in Moscow, ID, on June 13, 2014, Patti Anne Lodge got in my face and threatened me, saying she would "take me down". I respectfully ask the court to not provide her the opportunity to use this contest as a means

of carrying out her threat.
